The ICCBF provides the following services to the Ida Grove Community Recreation Center:

- Works with investment professionals to manage the funds in a diversified portfolio.
- Have policies in place and are ready to accept gifts of publicly traded securities, closely held securities, real estate and personal property.
- Have policies in place and work with donors and professional advisors to set up and accept deferred/planned gifts through bequests, life insurance, charitable remainder & lead trusts, gift annuities, retirement savings plans, etc.
- Provides gift acknowledgement, charitable gift substantiations, donor record keeping, pledge invoicing, etc.
- Provides additional 20% Endow Iowa tax credit to eligible donors.

Betterment Funds

If you would like to support the recreation center with a financial contribution, there are five different funds available to give towards:

Pool Endowment Trust



This fund was made possible by a \$200,000 donation by Leone Godbersen. The Trust is located at the United Bank of Iowa. The fund is available for pool repairs and improvements.

UBI Trust



This Fund was made possible by a \$30,000 donation by the United Bank of Iowa. This is a general fund for operation & maintenance, repairs, or improvements.

Endowment Fund



This Fund was made possible by a \$100,000 donation by Dick Bogue. This fund has been established for future equipment needs and facility improvements. Donors to this fund are eligible for a 20% Endow Iowa Tax Credit.

Sustaining Fund



This fund was created to help defray the operating and maintenance costs of running the facility. The facility operates throughout the year with a substantial operational deficit.

Scholarship Fund



This fund was created to assist lower income families with the cost of memberships and recreational programming for youth. An application process will determine the distribution of funds.

Donations of \$500 - \$4,999 will be recognized on our Donor Wall inside the front door of the Recreation Center. Donations of \$5,000 or more will be recognized on a perpetual plaque by the front desk.
